

Warranty Statement

This warranty which applies to generating sets sold by F.O TECHNOLOGIES LIMITED (herein after referred to as “ the company”) For all **YIHUA** products the product is covered under warranty for the period of 12months provided the Gen-set is COMMISSIONED BY F.O TECHNOLOGIES LIMITED from date of startup or 1000 hours whichever comes first and extended 2000hours or 12 months provided is under service contract with F.O TECHNOLOGIES LIMITED.

N; B For all **FGWILSON** products the product is covered under warranty for 12months or 2000hours whichever comes first from the date of commissioning.

N; B For all **YORC** products the product is covered under warranty for 48months or 3500hours whichever comes first from the date of commissioning.

The Company's Responsibility

If a defect in material or workmanship arises during the warranty period the company will take care of that.

- Replace or at the company's discretion repair the defective parts.
- Provide for reasonable and customary labor costs to correct the defect.
- Provide for the cost-of-service supplies such as coolant oil and filters which are made unserviceable by the defect.

The User's Responsibility

- Installing, operating and maintaining the generator set in accordance with manufactures' instructions.
- Making generator set available for repair as soon as the defect has become apparent.
- Accepting the company's sole judgment as to whether the faulty part is defective in materials or workmanship.
- Labor costs, except as stated under “ the company's Responsibilities” including costs beyond those required to disconnect the product to its attached equipment, mounting and support systems.
- The cost and risks for transport/shipping and other charges associated with the replacement of the repair parts.
- Settlement of area boys & community issue(s).
- Competing any outstanding payments for the purchase of equipment, parts or services relating to equipment under warranty.

Expiry of Warranty & Limitation

At the end of warranty period for **YIHUA, FGWILSON AND YORC PRODUCTS** the company shall under no circumstances be held liable for any special direct, indirect incidental or consequential damages.

Note: The Generator(s) will not be under warranty if not commissioned, also if corrective and preventive maintenance was not carried out by the Company during the WARRANTY Period but by a third party which was not assigned by company.

Far locations far from our branches coverage the customer need to pay for transportation & responsible for engineer(s) stay.

- Defects due to the user's improper installing, unbalanced load, use of unapproved oil or filters, use of improper or contaminated fuel lubricant, coolant, unsuitable storage before or commissioning, any form of inadequate maintenance.
- Repairs required because of failure to perform periodical inspections, services and/or perform routine checks and maintenance as specified in the Owner's Handbook.
- Topping of oil, as it is the customers responsibility once it is due to normal oil consumption. This is mostly common for big capacities, which might require topping of oil, before it is due for service every 200 running hours
- Alterations or repairs or parts used, not supplied, or approved by F.O TECH LTD and not authorized by the company in writing.
- Any operational cost more than the Company's range or outside the stated site conditions.
- Failure attributed to Normal wear and tear. Damage to parts, fixtures, housings,
- Attachments and necessary items that are not part of the Generating set.
- Negligence, accidents, or misuse.
- Owner or operator abuse or neglect of such: operation without use of adequate coolant or lubricants; over fueling; over speeding; lack of maintenance to lubricating, cooling or air intake systems; late servicing and maintenance, starting, warm-up, run-in, or shutdown practices, or for progressive damage resulting from a defective shutdown or warning.
- Failed components claimed under warranty remain the property of the Company. The Company has the right to reclaim any failed component that has been replaced under warranty.
- This warranty does not cover costs resulting from difficulty in gaining access to the generating set and of cosmetic damage to enclosure.

Note; Gen-set should be loaded at minimum 30% capacity and Maximum 70% capacity for optimum performance. if under loaded or over loaded the company shall not be liable for any damage that arises from user's mis operation. Overload is not acceptable.
